### **Annual Fee**

(1) Annual dues: US\$ 1,500

Member name be listed on IPLAC world recognized institutions (list accessible in IPLAC website for members login only).

(2) Annual dues: US\$ 2,500

Member name be listed on website front page of the IPLAC world recognized institutions (list display to the public).

#### **Member Benefits**

- (1) Authorize to conduct IPLAC designed courses and qualify the recipients with one certificate which proposed by franchisee himself after granted an agreement with IPLAC (list accessible in IPLAC website to member login only).
- (2) Franchisee can tailor made the courses and apply for additional certificates recognized by IPLAC And IPLAC will charge US\$ 500 for any additional certificate annually.
- (3) For new franchisee, IPLAC will provide license and an acrylic IPLAC partnership signboard (postage excluded).

(1) Teaching methods:

A. In class: curriculum according to the syllabus provide by IPLAC

B. On-line course: provide by IPLAC with online course materials.

(2) Test method:

A. Field test:

Questionnaire will be provided by IPLAC to the franchisee that is responsible to conduct the field test. Testers key-in the answers and sent them to IPLAC.

Qualified testers will receive the certificates from IPLAC after evaluation.

**B.** Online test:

Online test will be conducted by the IPLAC directly. Qualified testers will receive the certificate from IPLAC after evaluation.

(3) Fee structure:

## **Course Fee**

(A) In Class:

US\$ 800/certificate (recommended), and totally pay to the franchisee. Teacher recruitment is responsible by the franchisee. Class must be conducted according to the syllabus provide by IPLAC.

(B) Online courses:

Course fee for each certificate is US\$ 200 which collected by the IPLAC and courses materials will be provided by IPLAC. If online course not available, the franchisee is responsible to provide in class course instead.

#### **Test Fee**

- (A) Onsite test fee is US\$ 100/testee and will be collected by the franchisee (one set of questionnaire will be provided by IPLAC).
- (B) Online test fee is US\$ 10/testee and will be collected by IPLAC (questionnaire will be provided by the franchisee).
